OVERVIEW OF THE PROGRAM

The Master of Laws (LL.M.) Program in Chinese Law is a graduate law program offered by Peking University Law School, focusing on Chinese civil and commercial law. The language of instruction is English.

Peking University is a pre-eminent university in China, well-known for her long history, rich culture, distinguished alumni, enlightened education policies and exciting campus life. Established in 1904, the Law School has become a leading institution for legal education and a potent force for legal development in China. The Law School frequently cooperates with the government, law firms and the business community in the development of cutting-edge legal, social and commercial policies. The Law School also has many international connections and partnership programs with leading universities and legal institutions. PKU Law School is ranked 22nd globally in QS 2025 for law, 1st in Chinese Mainland. Also, Times Higher Education World University Rankings 2025 Announced Peking University ranked 14th in the world and 1st in China for the discipline of Law.

With China's rapid economic growth and growing presence on the world stage, the knowledge of Chinese law has become an essential resource for international students and legal professionals engaged with China. Peking University Law School established the LL.M. Program in Chinese Law to address the needs of the international community in seeking a comprehensive and systematic understanding of Chinese law from a first-class legal institution.

This program provides intensive instruction in Chinese law. Leading faculty members will offer Chinese law courses specifically designed for international students. The teaching will be comprised of both lectures and small-group seminars. In addition, Peking University regularly attracts top scholars and practitioners in Chinese law and students will have first-hand access to such distinguished presenters. There are also optional subjects in non-law areas such as politics, economy and society to facilitate students' understanding of China's culture. Moreover, courses on Mandarin Chinese are available for the improvement of language skills and adaption to local life.

The LL.M. Program offers students opportunities to visit top law firms and other legal institutions, such as the Supreme People's Court of China, the Intellectual Property Court, and the law enforcement authorities in China, with a hope to avail them with a better comprehension of the Chinese legal system and its cultural underpinnings. The program office also offers assistance to students in seeking internship opportunities at top law firms. Through the program, students can establish a solid foundation for their career development relating to China.

This degree is an equivalent of Master of Laws degree currently offered to Chinese students. The duration of the program is 1-2 year. No more than 30 students will be admitted into this program in the year of 2026. Academic faculty advisors will be assigned to each student for his or her study and degree thesis. Chinese student counsellor in Peking University Law School will also offer help.

ADMISSION REQUIREMENTS


1. Applicants must be non-Chinese citizens with a valid passport. Residents of the Chinese mainland, Hong Kong, Macau or Taiwan who have emigrated to another country and are applying to Peking University as international students must present valid passport or citizenship documents dating from before April 30, 2020, along with proof of cancellation of Chinese nationality.

Note:The exit and entry administration authority of the public security organ of China reserves the right to judge whether an applicant still has Chinese nationality. If during the application period or even after the admission or registration the applicant is judged to be still holding Chinese nationality, his/her

- 2. Applicants should be healthy, both physically and psychologically, with no criminal record, and must abide by the laws and decrees of China and the regulations of Peking University.
- 3. Applicants for master's degree programs must have attained a bachelor's degree from a university/ college accredited by the Ministry of Education of China.
- 4. Applicants must have (1) a first law degree (J.D., LL.B. or the equivalent) from a law school, or (2) a Bachelor's degree plus substantial law-related working experience.
- 5. Applicants whose mother tongue is not English or who did not have a postsecondary education entirely conducted in English language must take the TOEFL or IELTS examination. The Program requires a minimum score of 90 in TOEFL IBT, or 6.5 in IELTS with 6.5 in IELTS writing.

Postsecondary education entirely conducted in English language should provide a statement or certificate issued by the Registrar (or equivalent) confirming that the sole language of instruction and assessment of the degree was English.

Note: Other circumstances will be accredited by the Admission Committee.





APPLICATION

Application Materials

Visit the International Student Service System (http://www.studyatpku.com), fill in the application and upload the following documents:

(I) Graduation and degree certificates and degree authentication in Chinese or English. For degree certificates in other languages, applicants are required to upload both the original copy and a notarized copy in Chinese or English. Degree diplomas awarded by overseas universities must be authenticated by the Chinese Service Center for Scholarly Exchange, Ministry of Education, P. R. China (CSCSE). Degree diplomas awarded by universities on the Chinese mainland must be authenticated by the Center for Student Services and Development, Ministry of Education, P. R. China (CSSD).

Note: Applicants who graduated before 2026 must upload their degree authentication report during the application period. Applicants expected to graduate in 2026 must provide an official letter from their current university stating their expected graduation date and submit their certificate of graduation upon being pre-admitted.

- (2) Official transcripts of the applicant's academic achievement, including courses taken and standards achieved. These must be original documents or notarized copies, either in Chinese or English.
- (3) A personal statement (including the research plan, about 1500 words; please click the link to download the template: https://isd.pku.edu.cn/en/downloads.php?cate=13).
- (4) Résumé (with coloured photo) and a copy of the "Commitment for Application". Please click the link to download the template for the Commitment: https://isd.pku.edu.cn/en/downloads. php?cate=13.

- (5) Two recommendation letters from professor(s) or associate professor(s) related to your major (or equivalent professionals with relevant academic title), either in Chinese or English. Once applicants submit a request, the application system will send a link to the recommenders, and the recommenders should click the link and complete the recommendation either by filling out the form online or by uploading the scanned copy of the signed letter. Click the link to download the template: https://isd.pku.edu.cn/en/downloads.php?cate=13.
- (6) Original or photocopy of the TOEFL or IELTS test scores, if your mother tongue is not English or did not have a postsecondary education entirely conducted in English. The latter case should provide a statement or certificate issued by the Registrar (or equivalent) confirming that the sole language of instruction and assessment of the degree was English.
- (7) Passport front page. Applicants must upload the front page of any ordinary passport(s) he/she has used continuously since April 30, 2020, and the current passport must be valid for at least three months after enrollment.
- (8) Table of contents and abstracts of the applicant's academic publications and any other original achievements in his/her field (if applicable).
- (9) A certificate or evidence of Chinese language proficiency (if applicable).

The applicant's passport details (including name, nationality, gender, date of birth, and uploaded photo) submitted during the application phase, once confirmed, cannot be modified prior to enrollment.

Applicants must thoroughly review and ensure that all required documents (including two letters of recommendation) are complete and meet the specified standards before submission. Consequences resulting from incomplete or non-compliant materials will be borne solely by the applicant.

Deadline for Application

Note: Applicants intending to apply for the Youth of Excellence Scheme of China Program Chinese Government Scholarship and the Chinese Government Scholarship "High-Level Postgraduate Program" must submit their applications in the first round. Applicants for other scholarships and self-funded applicants may submit their applications in the second round.

Application Fee

The application fee is 800 RMB.

Note: Applicants are required to pay the application fee online before the application deadline. RMB only, any other currency or traveler's check will not be accepted. Applications with incomplete documents or without application fee payment will not be processed. The application fee is NOT refundable.

Examination

Office of the LL.M. Program will review the applicant's basic qualifications. After passing the review, the application materials will be forwarded to the Admission Committee for the academic review. The Admission Committee will organize professional expert panels to review the applicants' academic dossiers. All the submitted application materials will be reviewed to assess the applicant's overall ability. A shortlist of applicants will be drawn up for the next step of examination.

The second examination round will be held in March 2026. The examination list, form, requirements and time schedule will be notified by the Office of the LL.M. Program. Please pay close attention to the Law School website, application email and WeChat.



The admissions expert panel will conduct a comprehensive assessment of the candidates' research capacity, language proficiency, innovation capacity and comprehensive quality in the second examination round and evaluate the candidates' ranking separately.

Admission Decisions

- I. On the basis of the Law School examination results, the School Admission Office will review and approve the preliminary admission list.
- 2. The preliminary admission list will be posted out before the end of May. Applicants should pay close attention to the latest related notice of Law School.
- 3. The pre-admitted candidates should download and print the application form and, together with other required original application documents (except for degree diploma and recommendation letters), deliver or mail the materials to Law School of Peking University.

4. In late June 2026, the International Student Division will issue an admission notice, Confirmation Form for Study in China (JW201/JW202) and other documents to the admitted students.

Official admission letters will be sent out after June 2026 by the Office of the LL.M. Program.

Enrollment

Admitted students will complete the registration procedures and enroll at Peking University in early September 2026. The specific time will be announced in the admission notice.

Admitted students must register at Peking University with their valid passport, valid visa and admission letter at the designated time. All students should present their original degree diplomas as required upon registration for the enrollment qualification review. Students with degree diplomas awarded by overseas universities should, in addition, submit the authentication report issued by the Chinese Service Center for Scholarly Exchange. Students who do not pass the enrollment qualification review will be disqualified from enrollment at Peking University.

Credit and Thesis Requirements

Students are required to enrol in a minimum of 37 credits including all compulsory courses and pass all course examinations.

In order to obtain the LL.M. degree, students must complete the master's thesis relating to Chinese law and pass the thesis defence. A master's thesis shall be 12,000 words or more, and be written in Chinese or English. A thesis that is written in English shall include a summary in Chinese of at least 3,000 Chinese characters. After approved by the Peking University Degree Committee, the students can receive the LL.M. Program's graduation certificate and the degree diploma for the Master of Laws.

Tuition Fee and Scholarships

(I) Tuition Fee

The tuition fee for this program is RMB 160,000.

Students should pay RMB 160,000 in the fall semester before registration. The tuition fee should be paid in full in RMB.

Visa, Medical Insurance and Accommodation

I) Visa

Students admitted to PKU should apply for a student visa at the Chinese Embassy/Consulate in their country with the letter of admission and the |W201/202 form. International students who will study in China for over 6 months are required to obtain an "XI" visa, which will only be valid for 30 days upon arrival in China; upon arriving in China, they must come to the International Student Division and apply for a Residence Permit within 30 days in order to obtain a legal status in China.

2) Medical Insurance

The Ministry of Education of China stipulates that all international students must be medically insured throughout their entire planned period of study. Students are required to purchase the "Comprehensive Insurance Plan for Foreign Students" on the day of registration. Students who do not have valid medical insurance will not be allowed to register.

3) Accommodation

On-campus accommodation will be provided to students with scholarships that cover accommodation. Selffunded students should find their own living accommodation on campus or off campus. Please note that students who live off campus must register with the local police station within 24 hours of arrival.

Library and Network Facilities

Students have access to a wide range of legal research materials through the library and electronic resources. Legal databases such as Lexis-Nexis, Westlaw, etc. are available in the Law School's library.
